## CAMP ELIM RULES AND REGULATIONS

**\*Please read the following list of rules and regulations and sign in the space provided.\***

1. The rental of Camp Elim facilities ***does not*** include sailboats, sailboards, motorboat, or any water-skiing equipment.
2. Camp Elim seeks to have as little impact as possible on the surrounding environment. We ask that you observe the following:
  - Do not pick flowers or any other plants.
  - Do not disturb any animals and respect the camp as their home.
  - Stick to marked trails when hiking in the hills.
  - Use the recycling receptacles provided.

**PLEASE NOTE:** To lessen waste, we strongly encourage the use of our dishes and industrial dishwasher while staying at the camp, in order to reduce our ecological footprint.

3. Vehicle parking is permitted ***only*** in designated areas along and across the main road in the lot. The service entrance is for drop-off and pick-up only, as well as wheelchair accessibility, and must be kept free of vehicles at all times. There is absolutely ***NO*** driving anywhere on the lawns, as the grounds are covered with an underground sprinkler system that is easily damaged by vehicles.
4. ***No smoking*** is allowed in any of the buildings.
5. ***No pets*** are allowed in any of the buildings.
6. The resident manager is in charge and renters are required to follow his/her instructions at all times, as pertains to proper behaviour and use of property.
7. We ask that ***11:00 p.m.*** be considered quiet time out of respect for others.
8. ***Arrival and departure:*** Please check in with the camp manager upon arrival and before departure. ***Check-out time is 3 p.m.*** on the last day specified on the rental agreement. ***Before leaving:*** Clean all areas used by the group, check for personal belongings, report any damage, and pay all fees.

*I have read the rules and recommendations above and agree to abide by them while staying at the camp. I also acknowledge that by signing this form, it is my responsibility to make sure that the rest of my party is aware of the above rules and regulations. I also acknowledge that any damages incurred to camp property will be the responsibility of the undersigned.*
